Statistics gathered for this report are based on the best available information at the time of drafting and could be subject to change based on files being under investigation or being reported at a later date.




#### **Crime Statistics Report Summary:**

In August 2025, the total number of reported incidents across the eight key crime indicators rose slightly, showing an increase of six occurrences compared to both July 2025 and the five-year average for the month (87).


Notable increases were observed in the categories of theft, mischief and sexual assault. A significant rise was seen in mischief offenses, which totaled 16 more occurrences than August 2024, and 13 more than the five-year average. This spike is partially attributed to a series of seven mischief incidents in zone C4 (Duggan Park), where vehicle and building windows were damaged. Crimes Against Property, as a broader category, also saw an increase of six reported incidents over the five-year average.

The fraud category recorded a slight increase compared to August 2024, however remained six occurrences below the five-year average. During the month, Camrose experienced a series of "Grandparent Scams." In response, the Camrose Police Service launched a public awareness campaign and in conjunction with other law enforcement agencies, a suspect was identified and subsequently arrested in September, 2025.


# August 2025 Eight Crime Indicators Map




# Eight Crime Indicators Heat Map – August 2025




# Eight Crime Indicators Heat Map for 2<sup>nd</sup> Quarter April - June, 2025




# Occurrence Zones Break & Enter and Thefts August 2025






#### August 2022, 2023, 2024 & 2025 Break & Enter and Thefts





### "Mandatory Alcohol Screening" (MAS) Statistics


In August 2025, a total of 245 Mandatory Alcohol Screening (MAS) tests were administered, resulting in 20 charges being laid under the Intermediate Roadside Suspensions (IRS) program. There were no charges related to the Alberta Zero Alcohol Tolerance (AZAT) for graduate drivers, and four 24-hour suspensions issued. There was 1 impaired by alcohol or drug occurrence during the month.

#### **Crimes Against Persons**


5 Year Monthly Average – 28

#### **Crimes Against Property**


5 Year Monthly Average – 88

#### **Drug Occurrences**


5 Year Monthly Average – 4








