


#### **Crime Statistics Report Summary:**

In September 2025, a total of 40 occurrences were reported across the eight crime indicators, representing an unprecedented low. This marks a 54% decrease compared to the five-year average for September, which stands at 87 occurrences.


The overall decline was primarily attributed to a significant reduction in property-related crimes. Property offences fell by 39% compared to the five-year average of 70 incidents. Specifically, substantial decreases were recorded in break and enters, thefts of motor vehicles, and theft under \$5,000. These categories showed reductions both in comparison to September 2024 and the five-year monthly average.

The downturn in these high-frequency property crimes is attributed to enforcement efforts, targeted patrols, offender management and community-based initiatives.


# September 2025 Eight Crime Indicators Map




# Eight Crime Indicators Heat Map – September 2025




## Eight Crime Indicators Heat Map for 3rd Quarter July - September, 2025




# Occurrence Zones Break & Enter and Thefts September 2025






#### September 2022, 2023, 2024 & 2025 Break & Enter and Thefts

#### "Mandatory Alcohol Screening" (MAS) Statistics


In September 2025, a total of ninety-two Mandatory Alcohol Screening (MAS) tests were administered, resulting in four charges being laid under the Intermediate Roadside Suspensions (IRS) program. There was one charge related to the Alberta Zero Alcohol Tolerance (AZAT) for graduate drivers, and one 24-hour suspension issued. There were no impaired by alcohol or drug occurrences during the month.

#### Drug Impaired Driving Tests

During the month of September 2025 there were no Standard Field Sobriety Tests (SFST) or Drug Recognition Evaluation Test (DRE) performed.

#### **Crimes Against Persons**


5 Year Monthly Average – 29

#### **Crimes Against Property**


5 Year Monthly Average – 70

#### **Drug Occurrences**


5 Year Monthly Average – 5








